

## 免費泊車之條款及細則：

1. 太古城中心停車場/星輝臺(太古城第十期)停車場：顧客必須出示即日有效之消費商戶機印收據正本、相關並金額相符之電子貨幣付款存根之正本或2張同日有效之MOVIE MOVIE Cityplaza 戲票票尾(以票尾上列印之電影場次日計算)及進停車場時所拍之八達通、Visa、銀聯或Mastercard信用卡方可換領泊車優惠。
2. 每套有效之收據可累積不多於2張不同商戶之即日機印收據，而每張收據必須為港幣100元或以上。每張收據只可被使用一次，收據上的金額不能分開計算作多次換領。
3. 每套有效之收據或每2張戲票票尾只可換領免費泊車優惠乙次。
4. 換領地點及開放時間：
  - (i) 太古城中心2樓顧客服務處(上午10時30分 – 晚上9時)
  - (ii) 太古城中心B2免費泊車換領處(上午8時 – 凌晨12時)
  - (iii) 太古城星輝臺(第十期)停車場繳費處(上午8時 – 凌晨12時)
  - (iv) TAIKOO+流動應用程式(適用於任何時間，惟僅只限於太古城中心停車場，並只適用於已啟動免觸式泊車服務之LIVE+會員)
5. LIVE+會員可透過TAIKOO+流動應用程式換領太古城中心停車場免費泊車。會員須於「免觸式泊車」頁面點擊「兌換」，再選擇「使用收據」，揀選已批核之即日消費收據，或點擊「上傳收據」即時上載即日消費收據。經系統批核後，即可換領免費泊車優惠。
6. 下列商戶的消費單據適用於本泊車優惠：太古城中心任何商戶、餐飲指南上標註為綠色的太古城及東隅酒店食肆及[太古坊指定商戶](#)。不包括英皇道1111號、太古灣道12號及14號之食肆及商戶，如湊湊甄選、nodi、Brew Job、翠園、潮庭、菲力偉女子健美中心、奧迪、ZEEKR、Air Fitness及挑戰者。
7. 所有有效之商戶機印收據正本及相應電子貨幣付款存根正本必須為即日消費收據並須清楚印有消費日期、商戶名稱、發票號碼及付款方式。
8. 本推廣活動只接受電子貨幣消費，包括信用卡、借記卡、易辦事、Apple Pay、Google Pay、Samsung Pay、支付寶、微信支付、銀聯雲閃付、拍住賞、PayMe、八達通等。(以2張同日有效之戲票票尾換領泊車優惠除外)
9. 其他付款方法如現金、現金券、禮券、會員卡、禮品卡、儲值卡或入帳卡付款等恕不接受。
10. 本推廣活動**不接受**已取消、退款、偽造、欺騙或未誌帳的交易、手寫收據、單一信用卡收據、重印或影印收據、損毀收據、購買現金券、禮券、贈券及禮品卡之收據、會籍費用收據、學費收據(冰上皇宮溜冰學校)、購買郵票之收據、銀行所發出之收據及太古城中心停車場泊車費收據、於商戶網頁上/第三方平台支付進行之消費或購物、購買金粒、金條及供金會之收據、銀行服務、電訊服務、停車場服務、酒店服務、慈善捐款、儲值卡(包括購買及增值)、商戶會員卡(包括購買及增值)、八達通(包括購買及增值)，或任何訂

金之消費單據。

11. 逾期收據、收據副本、影印本、重印收據、分拆之單據、手寫收據、被退款收據、撤銷收據、重用及損毀收據恕不接受。
12. 合資格之消費金額為扣除收據上列明之所有商戶禮券、禮品卡、優惠、折扣之淨金額；會員卡內之儲值金額並不當作電子貨幣交易。
13. 每輛車每次只可於太古城中心停車場或於星輝臺(太古城第十期)停車場享有最多八小時免費泊車優惠(星期一至日及公眾假期)。如停泊時間超過優惠時段，所有額外泊車時間將會以一般泊車收費計算。
14. 所有優惠不可更換或兌換成現金。
15. 此優惠不可與其他泊車優惠同時使用。
16. 太古地產管理有限公司職員有權於顧客換領免費泊車優惠時，於所有收據或戲票票尾正本正面上蓋章。職員亦有權以相片記錄收據或戲票票尾作稽核之用。如收據或戲票票尾已被蓋上印章，太古城中心商戶有權拒絕相關交易之退款。如顧客進行任何退款後之總消費金額低於上述門檻，太古地產管理有限公司有權要求顧客退還已換領之泊車優惠。
17. 太古地產管理有限公司職員有權要求顧客出示相關易辦事、信用卡、扣帳卡、八達通、銀聯卡，或用作交易的智能裝置上的Apple Pay、Google Pay手機程式、Samsung Pay手機程式、支付寶手機程式、微信支付手機程式、銀聯雲閃付手機程式、拍住賞手機程式及PayMe，當中須載有裝置帳戶號碼，以便核對有關交易資料。
18. 太古城中心各商戶、太古城食肆、太古坊指定商戶或東隅酒店之職員均不可代客換領泊車優惠。
19. 優惠期有限，太古地產管理有限公司有權隨時終止、更改或修訂各項條款及細則而毋須事先通知。
20. 若有任何爭議，太古地產管理有限公司擁有最終決定權。

## FREE PARKING – TERMS & CONDITIONS:

1. Cityplaza Car Park / Sing Fai Terrace (Taikoo Shing Stage X) Car Park: To redeem the free parking offer, customers must present the **valid same-day original machine-printed receipts and the corresponding original electronic payment slip with matching spending amount, or two valid same-day MOVIE MOVIE Cityplaza movie ticket stubs (counted by the screening date printed on the movie ticket stubs)**, together with the Octopus Card, Visa, UnionPay or Mastercard used for car park entry on that same day.
2. Each set of valid receipts can accumulate no more than 2 different same-day machine-printed receipts from different merchants. Each receipt must be worth HK\$100 or more. Each receipt can be used once only, and the amount shown on the receipt cannot be split.
3. Each set of receipts, or every two valid same-day MOVIE MOVIE Cityplaza movie ticket stubs can be used only once for this free parking redemption offer.
4. Redemption venues and opening hours:
  - (i) Customer Service Counter, 2/F, Cityplaza (10:30am – 9pm)
  - (ii) Cityplaza Parking Redemption Counter, B2, Cityplaza (8am – 12am)
  - (iii) Sing Fai Terrace (Stage X) Car Park, Shroff Office (8am – 12am)
  - (iv) TAIKOO+ App (applicable at any time, but only for Cityplaza Car Park and exclusively for LIVE+ members with contactless parking service activated)
5. LIVE+ members can redeem free parking for Cityplaza Car Park via the TAIKOO+ App. Members need to tap “REDEEM” on the “Contactless Parking” page, then select “USE RECEIPTS” to choose the approved same-day spending receipt(s), or tap “UPLOAD RECEIPT(S)” to upload a same-day spending receipt(s) instantly. Upon receipt(s) approval, the free parking can be redeemed accordingly.
6. Receipts from the following merchants are valid for this Free Parking offer: All Cityplaza merchants, Taikoo Shing and EAST Hong Kong dining outlets that are coded green in the dining guide, and [designated Taikoo Place merchants](#). Excludes dining outlets and merchants at 1111 King's Road, 12 and 14 Taikoo Wan Road, which includes but not limited to Coucou Reserve, nodi, Brew Job, Jade Garden, Chiuchow Garden, Phillip Wain, Audi, ZEEKR, Air Fitness and Challenger.
7. Each original machine-printed receipt, together with the customer's corresponding original electronic payment slip, must be a same-day transaction receipt that clearly indicates the transaction date, merchant name, invoice number and payment method.
8. This free parking offer is valid ONLY for electronic payment by credit card, debit card, EPS, Apple Pay, Google Pay, Samsung Pay, Alipay, WeChat Pay, UnionPay App, Tap & Go, PayMe, Octopus Card etc. (except redemption of the free parking offer with two valid same-day MOVIE MOVIE Cityplaza movie ticket stubs)
9. Other modes of payments, including cash, cash coupon, merchant membership cards, merchant stored-value cards, gift cards, and charge cards, will **NOT** be accepted.
10. The following receipts are **invalid** redemption purposes: cancelled, refunded, forged, fraudulent or unsettled transactions, handwritten receipts, standalone credit card receipts, reprinted or photocopied receipts, damaged receipts, purchases of any cash coupons, gift certificates, complimentary tickets and gift cards; as well as receipts for membership fees, tuition fees (Ice Palace Skate School), stamp purchases, banks, Cityplaza parking fees, online transaction orders from merchant websites or third-party payment platforms; purchases of gold pellets, bars or deposits for the gold saving club; and receipts showing purchases or spending relating to banking services,

telecommunications services, car parking, hotels, charity donations, stored-value cards (including purchase and top-up), merchants' membership cards (including purchase and top-up), Octopus cards (including purchase and top-up) or deposits of any kind of transactions.

11. Expired, duplicate, photocopied, reprinted, split payment, handwritten, refunded, withdrawn, reused and damaged receipts will be considered **invalid**.
12. The spending amount eligible for redemption is the net amount spent after all merchant cash vouchers, gift cards, offers and discounts listed on the transaction receipt have been deducted. Payments by membership card credits are **NOT** eligible for redemption.
13. Each vehicle is entitled to a maximum of eight hours (Mon – Sun & PH) free parking at Cityplaza or Sing Fai Terrace (Taikoo Shing Stage X) Car Park on one visit only. Regular hourly rates will apply for every additional hour of parking beyond the free parking entitlements.
14. All redemptions are non-refundable and non-exchangeable.
15. This offer cannot be used in conjunction with other parking privileges.
16. Swire Properties Management Limited staff reserve the right to stamp the front side of all original eligible receipts presented or movie ticket stubs for redemption. Staff also reserve the right to record the receipts or movie ticket stubs by camera for verification. Cityplaza shops may reject any refund in cases where receipts or movie ticket stubs have been stamped for redemption. Cityplaza reserves the right to request customers return redeemed parking privileges if the required spending threshold is no longer met after such a refund.

Swire Properties Management Limited staff reserve the right to require customers to present their relevant credit card/debit card/EPS/Octopus card/UnionPay card, or Apple Pay/Google Pay/Samsung Pay/Alipay/WeChat Pay/UnionPay App/Tap & Go/PayMe mobile app on the original electronic payment device, with the device's account number shown, and with corresponding payment records for verification purposes.
18. Staff of Cityplaza merchants, any dining outlets at Taikoo Shing, designated merchants at Taikoo Place and EAST Hong Kong are not allowed to participate in this promotion, and are not allowed to redeem the offer on behalf of their customers.

20. Swire Properties Management Limited reserves the right of final decision in the case of any dispute.
