

## 太古城中心「利物浦國際足球學校 - 足球體驗」條款及細則

- 「利物浦國際足球學校 - 足球體驗」登記方式如下：
  - LIVE+會員可於 2024 年 7 月 24 日至 8 月 4 日期間親臨 2/F LIVE+服務處，為 6 至 9 歲的子女(即「參加者」)按年齡組別及課堂時間報名，並以現金繳付 HK\$200 及換領入場證。
  - Taikoo Place App 會員可於 2024 年 7 月 24 日至 7 月 31 日期間透過 Taikoo Place 流動應用程式，為 6 至 9 歲的子女(即「參加者」)換領入場名額，並於 2024 年 8 月 1 日至 8 月 4 日下午 8 時前，前往 2/F LIVE+服務處以現金繳付 HK\$200 及領取入場證。
- 領取入場證時，會員須填寫及簽署 (i)風險和免責確認書，以及 (ii)參加者資料登記表格，以表示同意讓參加者參與「利物浦國際足球學校 - 足球體驗」活動及同意太古地產有限公司的隱私政策。

**Cityplaza “LFC International Academy – Soccer Clinic” Terms & Conditions:**

1. LIVE+ members or Taikoo Place App members can register for “LFC International Academy – Soccer Clinic”, details as follows.
  - a. From 24 July 2024 to 4 August 2024, LIVE+ member can register for children aged 6 to 9 (i.e., the “Participant”) by visiting 2/F LIVE+ Concierge in person to pay HK\$200 **in cash** and redeem the entry ticket.
  - b. From 24 July 2024 to 31 July 2024, Taikoo Place App members could register for children aged 6 to 9 (i.e., the “Participant”) by redeeming entry quota via Taikoo Place mobile application. After redemption, Taikoo Place App member is required to pay HK\$200 **in cash** and pick up the entry ticket at 2/F LIVE+ Concierge in person from 1 August 2024 to 4 August 2024 before 8pm.
2. Members are required to sign and submit (i) Acknowledgement of Risk and Release, and (2) Submission Form for Participant’s Information during entry ticket redemption, to agree to allow his/her child to participate in “LFC International Academy – Soccer Clinic” and consent to Swire Properties Management Limited’s privacy policy.

5. The workshop group selected cannot be changed after redemption of entry tickets. All entry tickets redeemed are non-refundable, non-exchangeable, and cannot be exchanged for cash. Participant must arrive at the event venue 15 minutes before the workshop begins. Latecomers will not be entertained.
6. Participants must present this valid entry ticket to participate in the event. Each ticket allows entry for one participant aged 6 to 9 and one accompanying parent/guardian. Participant will not be allowed to attend the class if not accompanied by a parent/ guardian.
