



條款及細則

1. 「松滿福氣」香薰包 DIY 體驗 (下稱 體驗活動)推廣期為 2026 年 1 月 30 日至 3 月 3 日晚上 9 時(包括首尾兩日)或至額滿即止。
2. LIVE+會員於太古城中心及太古城指定商戶，以電子貨幣單一消費滿 HK\$200 並於消費當日經 TAIKOO+ App 成功上傳合資格收據，即可於同日參加體驗乙次。
3. 體驗活動參加詳情如下：
 - i. 地點：太古城中心, G/F (近 G008 號店 POPMART)
 - ii. 日期及時間：2026 年 1 月 30 日至 3 月 3 日(包括首尾兩日)或至額滿即止 (星期一至五: 12pm – 9pm ; 星期六、日及公眾假期: 11am – 9pm)
